ITEMS MUST BE BROUGHT TO THE REAR OF THE MUNICIPAL BUILDING IN TANNERSVILLE, PA AND PLACED IN CONTAINERS PROVIDED FOR THAT PURPOSE. LIMIT OF ONE TRUCKLOAD PER DAY PER FAMILY UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE WITH POCONO TOWNSHIP. THE TOWNSHIP DOES NOT PICK UP ANY ITEMS.
